



# AWARD: DIGITAL NARRATIVES FOR SEXIST VIOLENCE PREVENTION

## BASES

### 1 AIM

The award is established with the objective of encouraging the presence of ideas, opinions, thoughts and expressions that emphasize the prevention of violence against women and that express arguments, opinions and ideas that contribute to the challenge of building a society free of this social scourge.

Other objectives are:

- encourage the use of technologies to form and express ideas and opinions
- give recognition to those who daily contribute to building a better society
- generate ideas and resources for the prevention of violence against women

### 2 PARTICIPANTS

Everybody can participate in this awards and the participation could be individual or collective. Minors must have the approval of their tutors.

### 3 CATEGORIES

It's been established a single category, in which everyone can compete, regardless of whether they are grouped or individually, or if they are older or younger age. One overall prize, which will go to the winning proposal is established.

### 4 HOW THE AWARDS WORK:

They may be submitted all works under the following conditions:

- The work must be published in a

virtual space before being sent to the contest.

- The work should be able to be read, viewed or heard in less than 10 minutes by an adult and trained person.
- Being an audio, video, multimedia or an image (photograph, illustration, drawing ...) or a set of them.
- Express an idea, opinion, reflection or expression that contributes to the prevention of violence against women.
- It must be in Catalan, Castilian or English.
- Have not been rewarded previously.
- The author or author or group gives permission to the organization to communicate (non-exclusive) the work during the 2014 through the PuntTIC.cat channel and associated social networks.
- This permission (non-exclusive) is maintained for 25 years in terms of the winning work.

Each person or group may submit up to 3 entries, but all of them must have been created by them. They could be asked to sign a statement.

Proposals must be accompanied by the documentation listed in the following section.

### 5 DOCUMENTATION

- Participant's name and surname, or the representative's name and surname (collective authorship).
- Telephone number.
- Specific URL where you the work could be found. This should be universally available at this URL until the jury awarded the prize.
- Title of the work.
- Declaration of individual or collective authorship.

## 6 VALUATION CRITERIA

The jury:

- The adjustment to the bases.
- The general interest of work.
- The originality in addressing the issue.
- The overall quality of the work submitted.
- The innovative character of the proposal.
- Comments that work could receive in the space where it's exposed.

## 7 TERM AND METHOD OF PRESENTATION

The information listed in the "documentation" must be submitted via email. The absence of any of the specified information may result in the exclusion of the work.

The deadline for submission of proposals is December 23, 2014.

Nominations will be sent to mailbox [oficina.tecnica@punttic.cat](mailto:oficina.tecnica@punttic.cat) before December 23, indicating in the subject line "narrative Award against gender violence".

The organization will acknowledge receipt of any and all proposals received; this confirmation is your proof of receipt. Proposals after the deadline will not be accepted in any case.

## 8 AWARD, JURY, DECISION AND AWARD CEREMONY

The winning entry will receive a commemorative certificate.  
The winning entry will receive a GoPro Hero camera.

The jury will be composed of the women

participants and organizers of the Punt TIC campaign of november.

Every woman juror is entitled to speak and vote. The jury's decision will be taken by simple majority of votes in favor of a proposal. In the event of a tie, the vote of the president of the jury is quality.

The jury will interpret and supplement the award criteria, supplying the gaps that may exist and to resolve any doubts that may arise.

The decision will be final, and will be made public on Wednesday, January 21, 2015 during the Social Internet Day, but the person or group winner will be informed in advance to facilitate the presence at the Award Ceremony. After that, the winner proposal will be published at [PuntTIC.cat](http://PuntTIC.cat).

## 9 PRIVACY AND PROTECTION OF PERSONAL DATA

Intellectual and / or industrial property rights of the work submitted to the competition belongs to their authors.

The information submitted with the work may be inspected by any person (other than the contact phone number of the participant), by asking for this through the mail box of the contest. It is the responsibility of participants skip those personal data that they don't wish to be consulted, but this omission may result in the exclusion of the participant works.

The organization is committed to compliance with current legislation regarding the personal data that are included in the participation in the contest.

## 10 ACEPTACIÓN DE LAS BASES

The submission of the application presupposes knowledge and acceptance of the rules of the competition by all involved in the bid.
